

CORRECTION TO ISSUE NINETY

The October-December 2017 newsletter was in error concerning the donation from Butler Rural Electric Cooperative. That donation will be dispensed, not for the Historical Marker, but for the renovation of the Town Hall. Again, we are exceedingly grateful to them for their interest in preserving local history and aiding our historical society in preserving the Crosby Township Town Hall.

CHRISTMAS CONTRIBUTION

There was a \$75 donation made to the Miami White-water United Methodist Church food pantry, and \$75 to the Kris Kringle Chest for local needy families in December 2017.

GIFT FROM KNIGHTS OF PYTHIAS

The Knights of Pythias that was located in New Baltimore disbanded in 2017. As it was a non-profit organization it must donate any funds to another non-profit organization. The remaining members voted to donate the money left in their treasury amounting to \$3,324.96 to Crosby Township Historical Society, specifically for the Town Hall restoration. We are very appreciative that they chose us as the recipient of this gift.

TOWN HALL RESTORATION

The past few months work on the town hall mostly consisted of nailing drywall over the bottom half of walls. The top part is waiting for insulation to be blown in between the drywall and outer walls. Work halted during the holidays. Finding a good insulation company is next on the list.

In addition to the Knights of Pythias gift cited above, the board has been seeking donations from community businesses asking them to consider our organization in their charitable giving plans. So far, we have received \$50 from Heyob Farms, \$50 from Alvis Materials, Inc., and \$200 from Welch Sand and Gravel. We sincerely thank these businesses, organizations, and others for their faith in our project.

WITHIN THOSE WALLS

The Crosby Township Historical Society treasures our log cabin gifted to us at our formation. Its deconstruction, and restoration was a labor of love for our early members. The cabin was given the moniker "Passmore Cabin" because the Elias Passmore family lived in the structure for over fifty years. Basic information on Elias' parents, birth, death and family were fairly easy to attain. However, the joys and sorrows that took place in that home were uncovered by D. Warmuth, historian of the First Presbyterian Church in Harrison. Notes were shared from church records on an event called the "Trial of Common Fame" taking place between May and September, 1855. Elias Passmore accused a tenant, D.H. Walker of having an affair with his wife Lucinda. From those notes:


Elias Passmore and Lucinda Lambert were married on 09 April 1848. They received part of the Passmore farm as a marriage gift. Parents, Henry and Elizabeth Stonebraker Passmore still lived on adjoining land. Lucinda's family was from Whitewater Township. Elias Passmore, age 25, and his wife Lucinda (Lambert) age 22, had a one year old daughter Clarenna (from 1850 census) born 25 October 1849.

Elias and Lucinda Passmore lived on lot 29 in New Haven (the original spot of the cabin.) He also owned lots 30 and 44 as shown in his final will and testament proven 26 Sept. 1904. In 1850 Henry D. Walker, better known as DH Walker, age 45, lived in Crosby Township with his wife, Mary, age 33, and their two children William H. Walker, age 3 and James Walker, age 1.

Several times during the trial it was mentioned that Lucinda had been visiting in Indiana. Her brother, during the year of 1855, lived in Indiana and had a daughter Helen, who was one year older than Clarenna. Lucinda Lambert Passmore disappeared after that 1850 census that shows the family. Divorce records are not available for this time due to the courthouse fire.

Daughter, Clarenna AKA Clara married Michael Kane and lived at 856 Lexington Ave. in Cincinnati. Clarenna died on 24 August 1924 and is buried at Spring Grove Cemetery (her burial record give her parents name as Passmore)..... She was not named in her father's 1904 will.

Elias Passmore married Ann Goshorn Denning 03 Feb 1859. She was born in 1821 in South Carolina. Together they had two children. Elias adopted Ann's four children left fatherless several years before. Elias and Ann lived on the Passmore property until their deaths in 1904 and 1911. He left his property and belongings to his wife Ann and heirs. Son, A.J. Passmore and his wife Isabella took over the family farm. In 1870 the real estate value was \$2,300. This tripled by 1900.

Henry D. Walker and his wife Mary had five known children after 1850. Mr. Walker was excommunicated from the First Presbyterian Church for failure to repent. Mary would have been allowed to continue to attend; her name never appeared as a member.

The Passmores were never members of the First Presbyterian. The church was used as a court house-which was common on the frontier. The trial took place eight months from beginning to end.....The Passmores and the Walkers are buried in New Haven Cemetery. There names are still visible on the old gravestones.




In Case You Missed it . . .

October's meeting gave us Thomas Stander who presented a program entitled "Eight Months in 1917 that forever changed Butler County and Surrounding Area." Tom covered the anti-German hysteria that grew up in our local areas during this time in World War I that created hardships for those of German decent. The government agencies that developed like the American Protective League that was supposed to aid in detecting German sympathizers brought about the arrest of individuals based on accusation with little support.

In November, CTHS member David Roessler gave a lecture and power-point program on his own personal experience of "Hiking the Pacific West Trail." David's 2015 solo hike along the Pacific Crest took two years of planning and preparation. His track from the Mexican border to British Columbia consisted of some 2,650 miles through national parks, forests, and wilderness areas bearing the desert heat and cold mountain temperatures. It took five and a half months, and forty-five pounds of weight loss to complete his goal.

On December 21st, members and guests enjoyed our Christmas meeting and party with wonderful food specialties contributed by many of our members. Guessing games were provided and everyone enjoyed this holiday event.
